INSTRUCTIONS FOR SUBMITTING A STATEMENT OF ENDORSEMENT

If the name of a person or organization is used in your Candidate's Statement or Measure Argument as endorsing the candidate or endorsing/opposing the measure, YOU MUST EITHER:

1. Use the name of the person or organization with a quotation made by the person on behalf of the person or by an authorized person on behalf of an organization. The quotation must have been disseminated to the public prior to its inclusion in the Candidate's Statement / Measure Argument and it must be identified in the Candidate's Statement / Measure Argument by its source and date (such as the name of the newspaper that is appeared in) and date of dissemination / publication. Examples for identifying the source of a quote are:

James Joyce, *The Oregonian*, 1/22/03
Bob Dole, *Time Magazine*, July 7, 2002
John F. Kennedy, *Profiles in Courage*, 1960

2. File a Statement of Endorsement signed by the person, or by an authorized person on behalf of an organization, stating that the person consents to the use of the name of the person or organization in the Candidate's Statement / Measure Argument. An organizations' name should only be used if the organization is endorsing the Candidate's Statement / Measure Argument.

This Statement of Endorsement should be filed with the Candidate's Statement / Measure Argument it relates to and must be filed no later than the Voters' Pamphlet filing deadline.

NOTE: If a Statement of Endorsement is not received, the person or organization whose name is mentioned will be edited from the Candidate's Statement or Measure Argument. If the information contained in the endorsement designation box on the front of this form does not match what is printed in the Candidate's Statement / Measure Argument, the Candidate's Statement / Measure Argument will be edited to match the Statement of Endorsement form.
