ColPac Welcomes Juliet Hyams to Our Team

Starting on September 1, Juliet will lead grant coordination efforts in the ColPac and Greater Portland Inc. regions.

Juliet comes to ColPac with many years experience in working with counties and cities to pursue, manage and implement significant grant funded projects. She has a deep understanding of NW Oregon and will hit the ground running in September. Through Juliet's expertise with state and federal grant applications, ColPac EDD will be offering assistance to cities, counties, ports and special districts across five counties, who are eligible under House Bill 2345, to identify and apply for grant-based funding opportunities.

The intent of this program is to provide support for organizations with little capacity to take advantage of recent and on-going funding packages. Funding opportunities span the state and federal level, many different agencies, and operate on strict deadlines. ColPac hopes to assist in the discovery, research and writing, and regional alignment of funding opportunities to leverage these federal spending packages for maximum benefit to our region. Much like the overwhelming nature of the funding, we anticipate an overwhelming need for these services. Over the coming weeks, we will be reaching out to all House Bill 2345 eligible organizations with details about our grants coordination program and how to request assistance.
