7. 501(c)(3) Possibility

a. Pros: will give us more autonomy with our event planning and ability to raise funds/increase our budget. We'd be in a better position to offer consistent support to arts organizations in our area.

Cons: a bit of work upfront, and to maintain, particularly on the accounting side of things

b. Things to note:

- Clatsop County will continue to support us, but cannot guarantee financial resources. May possibly be able to put something in writing to intend support in exchange for our work on the summit and economic survey
- ii. Filing Fees est \$275 we will likely need to come up with on our own
- iii. There is a lawyer who has offered to assist with the formation pro bono

- iv. Commissioner Wev suggested we reach out to the County Commission for their feedback on the possibility
