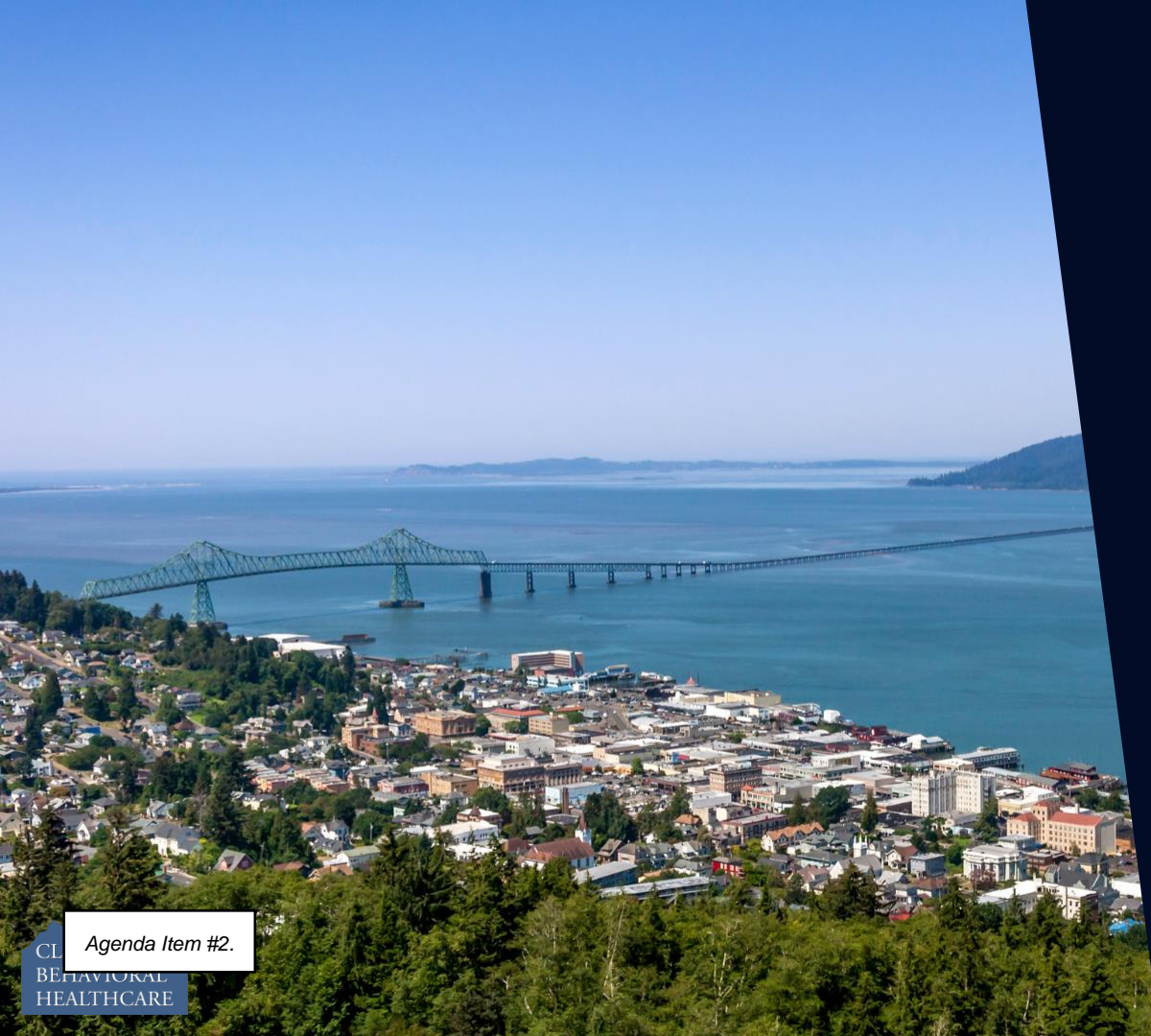

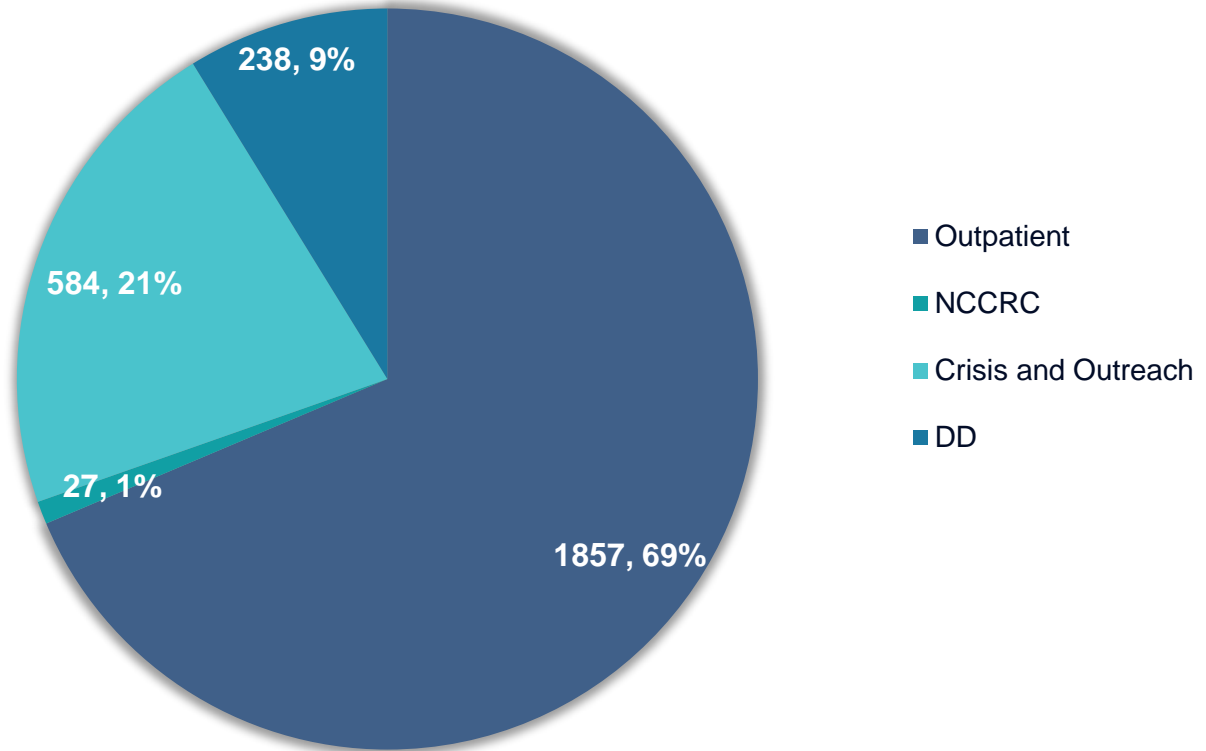

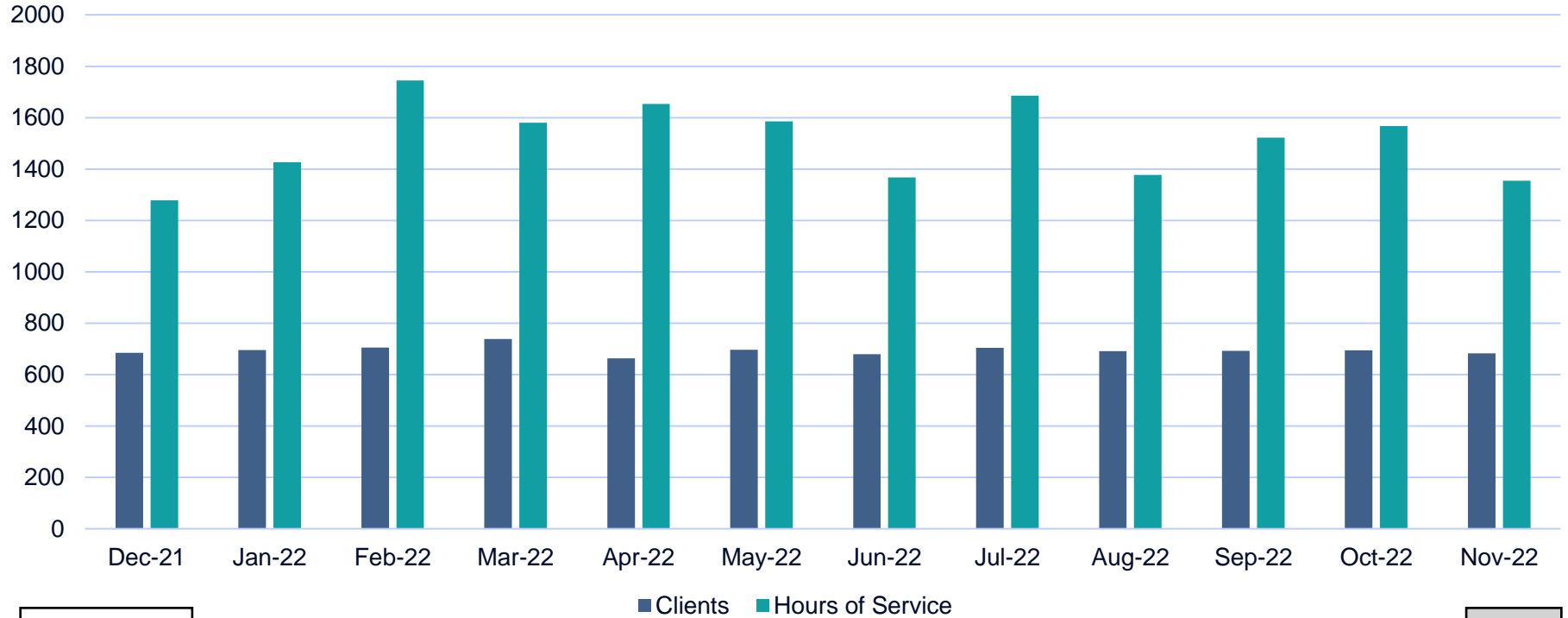

TOTAL CLIENTS SERVED | 12/01/2021 – 11/30/2022

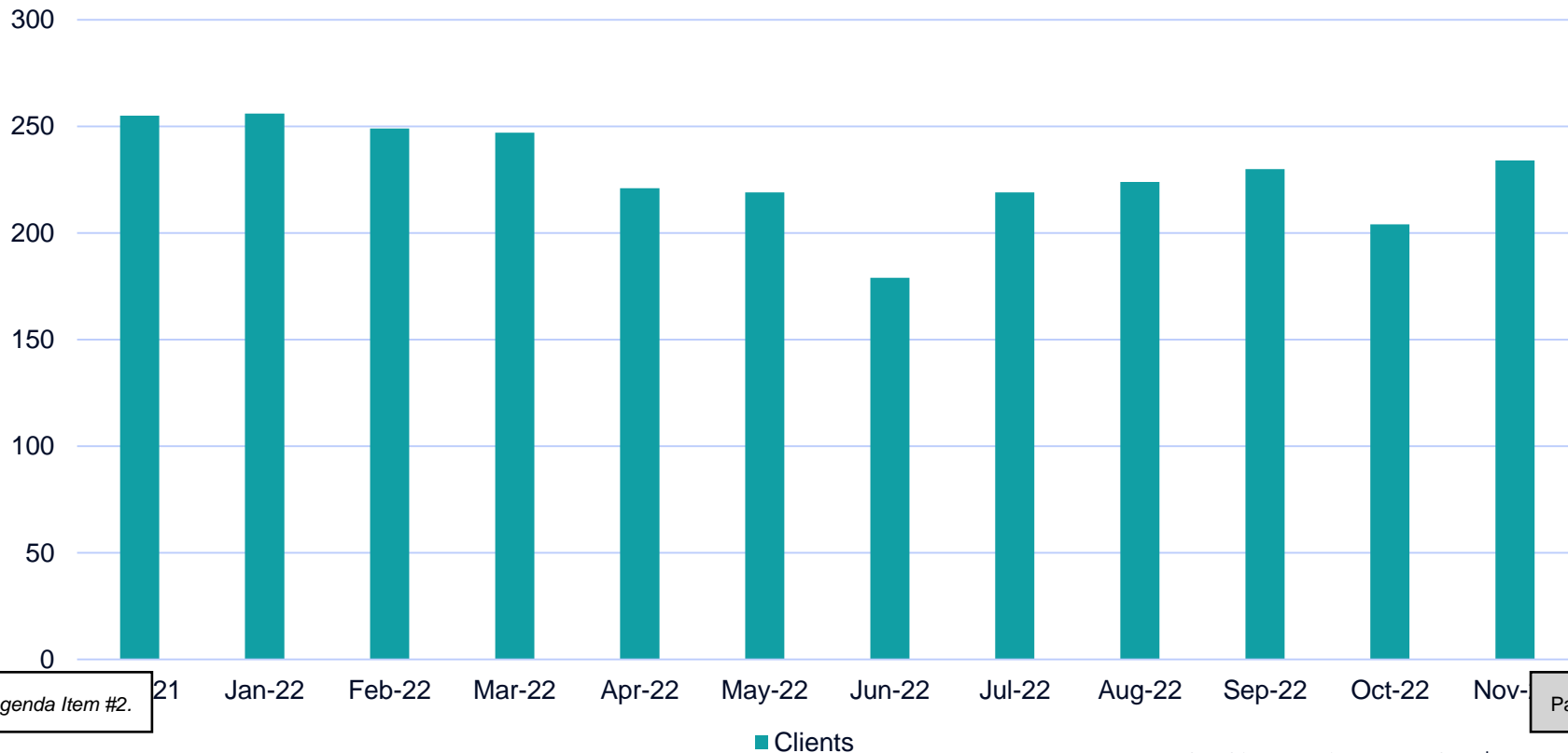


OUTPATIENT CLIENTS & HOURS OF SERVICE

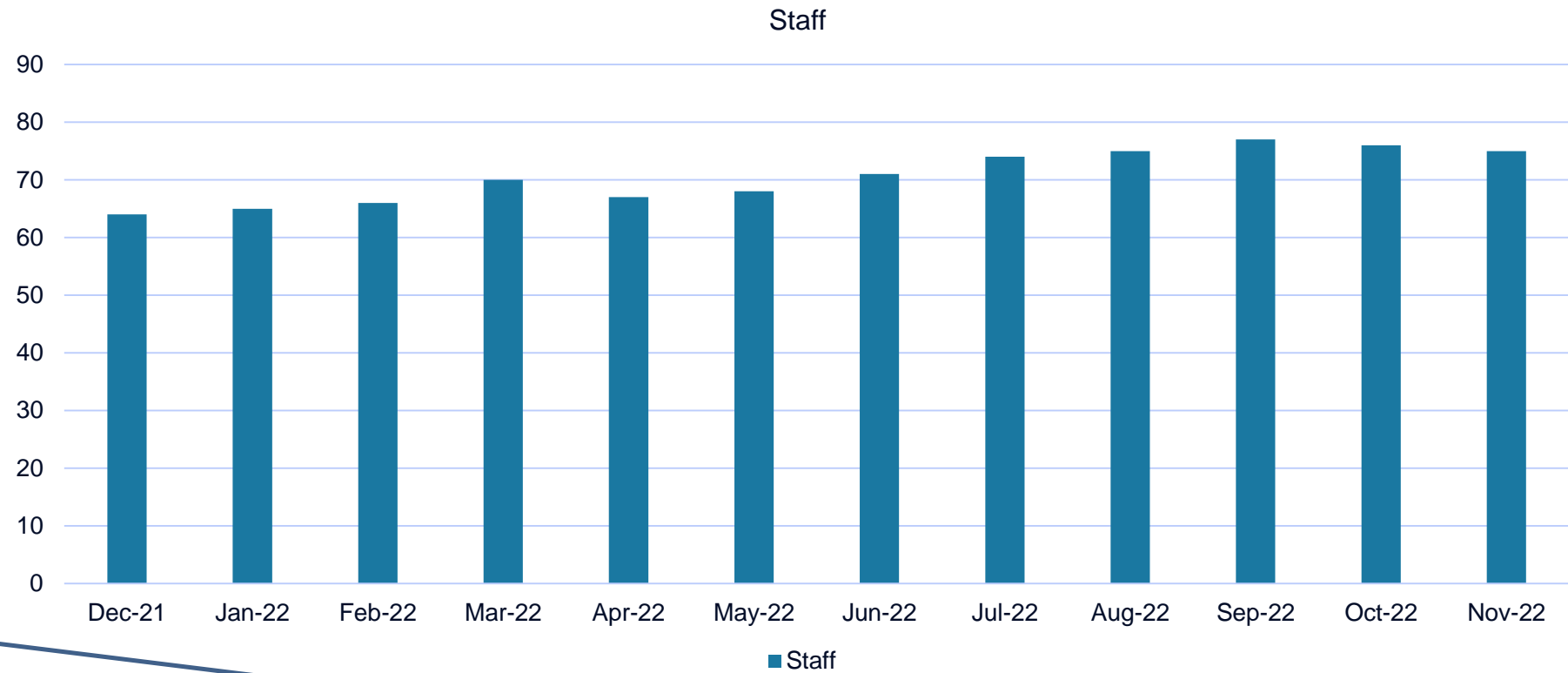

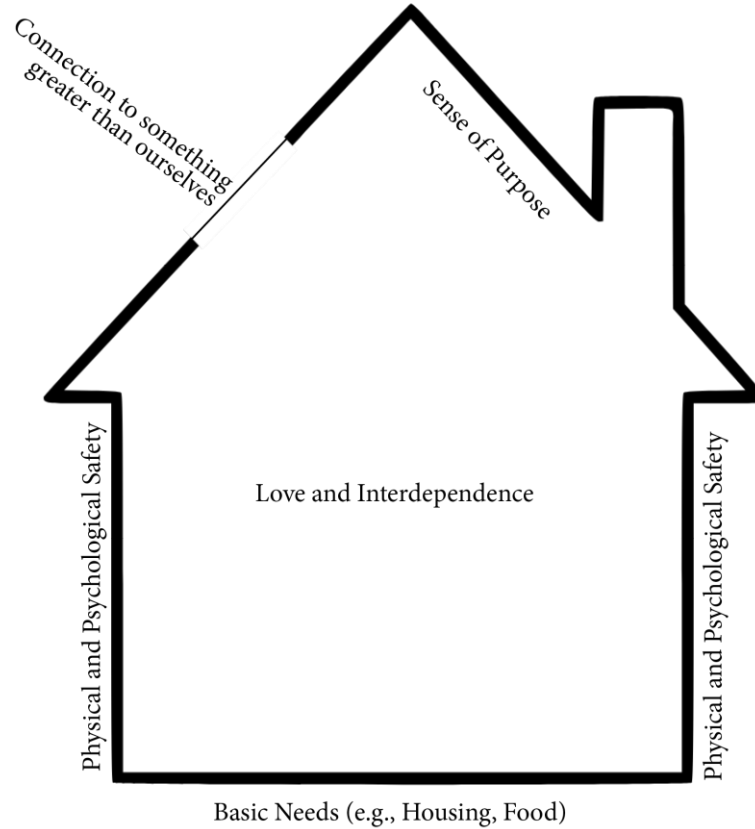

Topic: Comprehensive Plan Update

**Informational
Summary:**

Clatsop County began the process of updating its comprehensive plan in February 2019. This was the first holistic review of the entire 2,000+ page document since its original adoption in 1980. The update process experienced several stops and starts during the past four years, including adjustments to scheduling and to accommodate new technologies and meeting practices associated with COVID. Following several years of monthly public meetings by the six citizen advisory committees, and review by land use legal counsel, recommended drafts of the updated comprehensive plan and six community plans were presented to the Planning Commission.

The Planning Commission conducted public hearings on the Goals 1-14, Goal 19 and the revised community plans on August 9, 2022, and recommended the Board of Commissioners approve the updates as presented. Your Board was originally scheduled to conduct a first public hearing on September 14, 2022, but instead removed the items from the agenda in order to allow your Board additional time to review the materials and to provide additional comments to staff.

Since September 2022 planning staff have worked with the County Manager to review the draft policies along with associated Oregon Revised Statutes (ORS) and Oregon Administrative Rules (OAR) to identify actions that the County must take and items that are discretionary. This review is reflected in changes to the draft policies, which seek to distinguish between mandatory “shall” items and discretionary “should” items.

This work session is an opportunity for your Board to provide staff with feedback on the [most recent draft](#) of the updated comprehensive plan, which was provided to your Board on February 21. The draft only contains the policies related to each goal, along with a brief overview. The exception is Goal 2, which contains the framework for the County’s land use program and which also identifies and explains the six different land use designations that are the foundation for the County’s zoning designations. The narrative from the goals has been

placed into separate background reports which would be adopted by reference. Some goals, such as Goal 12 (Transportation) do not have background reports as those policies are drawn directly from the County's 2015 Transportation System Plan.

Goal 5, which is considerably complex has not been included in this latest draft of the comprehensive plan. Goal 5 will be scheduled for separate review and discussion with your Board at a future date.

This draft also does not include Goals 16 (Estuarine Resources), 17 (Coastal Shorelands) or 18 (Beaches and Dunes). Funding had been requested and approved in FY 22/23 to hire consultants to complete work on these highly technical goals. The RFPs were previously scheduled for review by your Board at a work session in October, but staff requested the item be delayed pending completion of the comprehensive plan update process.

The six community plans are also not currently included in this latest update, which is solely focused on Goals 1-4, 6-14 and 19.

REQUESTED INPUT AND NEXT STEPS

1. Staff is requesting input and direction from your Board regarding this most recent draft of the comprehensive plan. If your Board determines that the draft is generally ready to resume the adoption process, staff would then renotify DLCD and schedule the item for review by the Planning Commission and your Board. It is anticipated that the process would take approximately 3-4 months to complete.
2. Staff is also requesting direction from your Board regarding whether the RFPs for Goals 16-18 should be rescheduled for review by your Board at a future work session.
